## LIBRARY DIRECTOR'S REPORT

The library closed to the public on March 17, 2020 as a safety measure due to the COVID-19 outbreak.

Dick's Flooring will be installing the carpet in the Ralph Plumb Room during the closing. The estimated cost of the roof repairs, \$960, is below our insurance deductible.

Work is continuing on the meeting room.

Staff has completed weeding the non-fiction section. Staff is also reviewing and correcting errors in library records.

Director Maxwell has completed approximately 80% of the scheduled records disposal. The library website has been updated and FY2019 audit requests have been completed.

#### PRESIDENT'S REPORT
